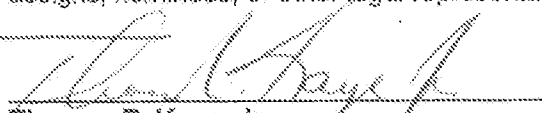

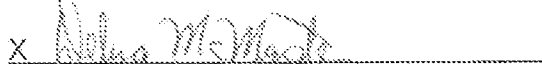
"OSCILLATING CUTTING BLADE"

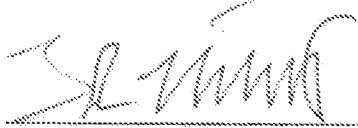

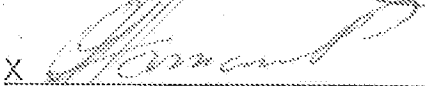
