Assignment

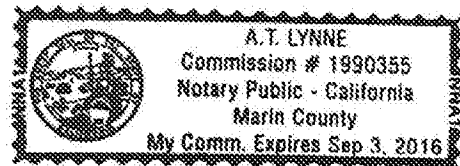

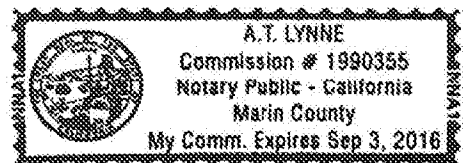
