PATENT ASSIGNMENT

WHEREAS, Lighthouse Capital Partners V, L.P., having a place of business at 500 Drake's Landing Road, Greenbrae, California 94904, obtained the intellectual property of Monosphere, Inc., having a place of business at 101 Redwood Shores Parkway, Suite 210, Redwood City, California 94065, in a peaceful foreclosure proceeding, and the intellectual property assets owned by Monosphere, Inc. as of the time of the agreement included certain U.S. and foreign patents and patent applications as set forth in Attachment A (hereinafter referred to as the "Monosphere Patents");

WHEREAS Lighthouse Capital Partners V, L.P. sold the entire right, title, and interest that Lighthouse Capital Partners V, L.P. had in Monosphere, Inc.'s intellectual property, including the Monosphere Patents, to Quest Software, Inc., having a place of business at 5 Polaris Way, Aliso Viejo, California 92656, by a Foreclosure Sale Agreement dated December 30, 2008 (hereinafter referred to as "the Foreclosure Sale Agreement");

WHEREAS Lighthouse Capital Partners V, L.P. (hereinafter referred to as "ASSIGNOR") and Quest Software, Inc. (hereinafter referred to as "ASSIGNEE") acknowledge that this Patent Assignment does not alter any of the terms of the Foreclosure Sale Agreement but is intended to be a confirmatory agreement for recordation with the United States Patent and Trademark Office concerning the Monosphere Patents as set forth in Attachment A; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby acknowledges that to the extent that it has the legal right to do so it has sold, assigned, and transferred, and by these presents does hereby sell, assign, and transfer, unto ASSIGNEE, its successors, legal representatives, and assigns, the entire right, title, and interest throughout the world in, to, and under the Monosphere Patents and all divisions, renewals and continuations thereof, and all patents which may be granted thereon and all reissues and extensions thereof, and all rights of priority under International Conventions and patent applications which may hereafter be filed for said improvements in any country or countries foreign to the United States, and all patents which may be granted for said improvements in any country or countries foreign to the United States, and all extensions, renewals and reissues thereof.

ASSIGNOR does hereby sell, assign, transfer, and convey to ASSIGNEE, its successors, legal representatives, and assigns all claims for damages and all remedies arising out of any violation of the rights assigned hereby that may have accrued prior to the date of assignment to ASSIGNEE, or may accrue hereafter, including, but not limited to, the right to sue for, collect, and retain damages for past infringements of the Monosphere Patents.
