
PATENT ASSIGNMENT

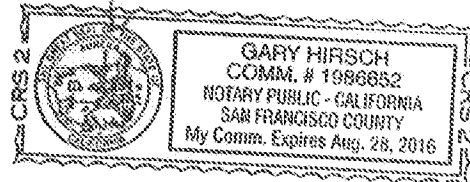
