ASSIGNMENT

WHEREAS, we, Teodoro T. Ianiro, of Concord, California, and Laurel A. Fisher, of Hayward, California, and William J. Mergens, of West Palm Beach, Florida, have invented a certain invention, entitled METHOD OF PREPARING A MUSCADINE POMACE EXTRACT, as described in the following patent applications:

Shaklee Corporation, its successors and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.

We confirm that at the time the invention was made, we were under an obligation to assign the invention to Shaklee Corporation.

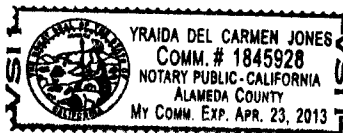

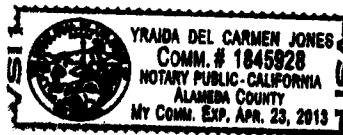
