(A) irrevocably assigns to Buyer:


- (1) its entire right, title, and interest throughout the world in and to:

- (B) agrees, upon request (and at the entire expense) of Buyer to execute all oaths, assignments, powers of attorney, applications and any other papers necessary to perfect Buyer's title in the foregoing.
