And Assignor does hereby request and authorize the Commissioner of Patents and Trademarks, US and its foreign counterparts to issue said LETTERS PATENT when granted, in accordance with this assignment.

Assignor further covenants and agrees with the Assignee that Assignor has a full and unencumbered title to the patent application and invention hereby assigned, which title Assignor warrants unto the Assignee, and Assignor further agrees that Assignor will, without demanding any further consideration therefor, at the request but at the expense of

the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining sustaining, extending, reissuing or reexamining United States and foreign LETTERS PATENT or the like for the said patent application and said invention, and for maintaining and perfecting the Assignee's right to said patent application and said invention and LETTERS PATENT particularly in cases of interference conflict, opposition and litigation.
