Assignor covenants for itself and its respective legal representatives that it has granted no right or license to make, use or sell said Patent, to anyone except said Assignee, that prior to the execution of this assignment, Assignor's right, title and interest in said Patent has not been otherwise encumbered, and that Assignor has not executed and will not execute any instrument in conflict herewith.

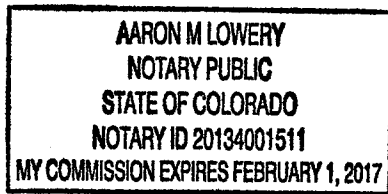
