PARTIAL RELEASE OF PATENT SECURITY INTEREST

THIS PARTIAL RELEASE OF PATENT SECURITY INTEREST (this "Partial Release") is given on August 5, 2013, by JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Collateral Agent") to MEASUREMENT SPECIALTIES, INC., a New Jersey corporation ("Grantor").

WHEREAS, said Confirmatory Grant was recorded in the United States Patent & Trademark Office on June 1, 2010 at reel/frame 24463/0953;


WHEREAS, Grantor is assigning all of its right, title and interest in, to and under the Patents to a third party and has asked the Collateral Agent to release its security interest; and
