ASSIGNMENT

WHEREAS, I, Marc Fervel, of Toulouse, France, hereinafter ("Assignor"), have invented certain new and useful improvements in METHOD FOR CONTROLLING A HIGH-LIFT DEVICE OR A FLIGHT CONTROL SURFACE, SYSTEM AND AIR- OR SPACECRAFT for which application for a U.S. Patent was made on December 6, 2012 as Application Serial No. 13/707,033 and which claims priority to U.S. Provisional Patent Application Serial No. 61/569,495 filed December 12, 2011 and EP 11193054.1 filed December 12, 2011.

Assignor further covenants and agrees that, at the time of the execution and delivery of these presents, Assignor possesses full title to the invention and application above-mentioned, and that he has the unencumbered right and authority to make this assignment.
