PATENT APPLICATION ASSIGNMENT

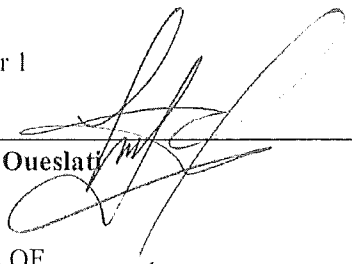

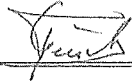

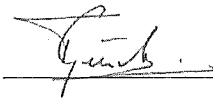
