Assignment of Invention

WIEDEMEIER, of 6164 Crestview Drive, North Syracuse, New York 13212 U.S.A.; Joseph M. CUSCHIERI, of 2398 NW 38th Street, Boca Raton, Florida 33431 U.S.A.; and Christopher E. MARCHANT, of 8830 Madeleine Drive, Baldwinsville, New York 13027 U.S.A., have invented certain new and useful improvements in an invention entitled APPARATUS AND METHOD FOR NEUTRALIZING UNDERWATER MINES, for which a provisional application was filed on March 16, 2012, and was identified in the United States Patent Office by Application No. 61/612,024, and for which an application for Letters Patent of the United States was filed on March 15, 2013, and which may be identified in the United States Patent Office by Application No. 13/840,223.
