## ASSIGNMENT

WHEREAS, David W. Taylor, Kevin C. McCarthy, Niall R. Lynam and Kenneth Schofield, residing at 75 Chateau Du Lac, Fenton, Michigan 48430; 5421 South Beehive, Tucson, Arizona 85746; 248 Foxdown, Holland, Michigan 49424; and 4793 Crestridge Court, Holland, Michigan 49423, respectively (hereinafter referred to as Assignors), have invented certain new and useful improvements in VEHICLE NAVIGATION SYSTEM FOR USE WITH A TELEMATICS SYSTEM for which an application for United States Letters Patent was filed on August 20, 2003, and assigned Serial No. 10/645,762.
