RELEASE OF SECURITY INTEREST IN PATENTS

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”) dated as of August 9, 2013 by BANK OF AMERICA, N.A., as administrative agent for the Secured Parties (as defined in the Credit Agreement referred to below in such capacity and together with its successors and assigns, the “Agent”), in favor of ENGILITY CORPORATION (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement (as defined below).

WHEREAS, the Grantors entered into that certain Credit Agreement dated as of July 17, 2012 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), pursuant to which the Grantor executed and delivered that certain Patent Security Agreement dated as of July 17, 2012 (the “Patent Security Agreement”) for recordation with the United States Patent and Trademark Office;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 17, 2012 at Reel 028572, Frame 0620;

WHEREAS, pursuant to the Patent Security Agreement, the Grantor granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in all of the Grantor’s right, title and interest in, to and under Patent Collateral (as defined below); and

WHEREAS, the Agent desires to terminate and release the Lien on and security interest in the Patent Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

The term “Patent Collateral,” as used herein, shall mean all patentable inventions and designs, all United States, foreign, and multinational patents, certificates of invention, and similar industrial property rights, and applications for any of the foregoing, including, without limitation, (i) each patent and patent application listed on Schedule A attached hereto (ii) all reissues, substitutes, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations thereof, (iii) all inventions and improvements described and claimed therein, (iv) all rights to sue or otherwise recover for any past, present and future infringement or other violation thereof, (v) all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, proceeds of suit and other payments now or hereafter due and/or payable with respect thereto, and (vi) all other rights accruing thereunder or pertaining thereto throughout the world.

The Agent hereby terminates, discharges and releases the Lien on and security interest in the Patent Collateral, without representation, warranty, or recourse.
