**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN PATENT RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN PATENT RIGHTS (this "Termination"), is dated as of August 9, 2013, and made by **ARES CAPITAL CORPORATION**, a Maryland corporation, located at 245 Park Avenue, 44th Floor, New York, NY 10167 ("Grantee") to **ZICAM, LLC**, a Delaware limited liability company ("Grantor"), located at 8515 E. Anderson Drive, Scottsdale, AZ 85255.

WHEREAS, pursuant to that certain Grant of Security Interest in Patent Rights, dated as of June 30, 2011, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Patents (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on June 30, 2011, at Reel 026533 and Frame 0795; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Patents," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the patents listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Patents and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Patents.
