## ASSIGNMENT

I hereby authorize and request the Patent Office Officials in all countries to issue any and all of said Letters Patents, when granted, to said ASSIGNEE as the assignee of our entire right, title and interest in and to the same, for the sole use and behoof of said ASSIGNEE, its successors and assigns, to the full end of the term for which said Letters Patents may be

granted, as fully and entirely as the same would have been held by us had this Assignment and sale not been made.

Further, I agree that I will communicate to said ASSIGNEE or its representatives any facts known to us respecting said Invention, and testify in any legal proceeding, sign all lawful papers, execute all papers relating to all divisional, continuation, continuation-in-part, extension, renewal, non-provisional or substitute thereof, and any renewal, re-examination and reissue of said Letters Patent, execute all necessary assignment papers to cause any and all of said Letters Patents to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said Invention in any and all countries.


