
ASSIGNMENT



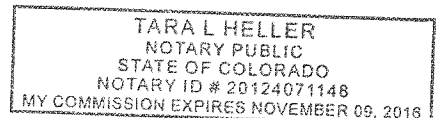

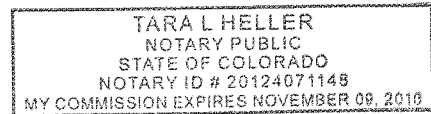
