**ASSIGNMENT OF UNITED STATES PATENT APPLICATION**

WHEREAS, We, STANTON CASEY SMITH and RANDALL J. MACH, both citizens of the United States of America, residing respectively at 1919 Malabar Drive, Germantown, Tennessee 38138 and 719 Wilson Street, Franklin Square, New York 11010, hereinafter referred to as "Assignors", have invented certain new and useful improvements disclosed in an application for Letters Patent of the United States titled DUAL CONTAINMENT PIPE SYSTEM AND METHOD OF INSTALLATION, transmitted to the United States Patent and Trademark Office for filing on July 11, 1995 (Express Mail No. EF 897 223 478); and

AND WE, HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE, HEREBY further covenant and agree that we will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.


