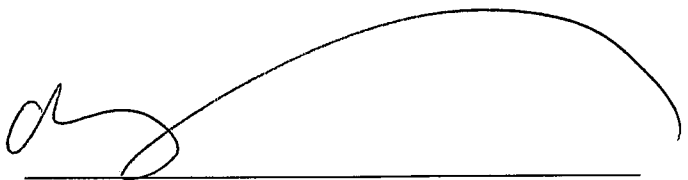
ASSIGNMENT
