ASSIGNMENT

WHEREAS, Russell A. Fink, Tommy O. Johnson, Shaun Hutton, and Kevin Z. Snow, hereinafter referred to as the ASSIGNORS, have made an invention as described in a United States patent application no. 12/570,702, filed September 30, 2009 entitled:

Identification and Verification of Peripheral Devices Accessing a Secure Network

THE ASSIGNORS here further agree to make, execute, and deliver to the ASSIGNEE, its successors, assigns, and legal representatives, upon request but at the expense of the ASSIGNEE, any and all papers, documents, affidavits, statements, or other instruments that may be necessary in the prosecution of the aforesaid application, and of any United States or foreign applications, and of any substitutions, divisions, continuations, or continuations-in-part of said application, or applications for reissues of said Letters Patents, and to aid the ASSIGNEE, its successors, assigns, and legal representatives in every way in protecting the said invention as may be requested, provided, however that they shall not have to pay any expenses arising from extending such assistance.

THE ASSIGNORS hereby covenant that they have the right to grant the foregoing assignment.

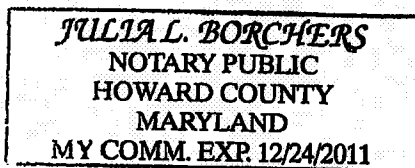

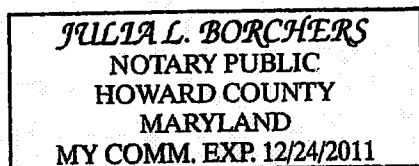

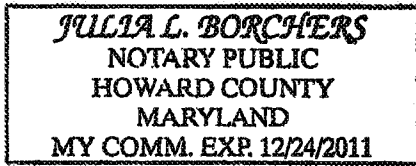
