DEED OF ASSIGNMENT

THIS DEED is made the *8th* day of *March* 2012

BETWEEN

("the Assignee")

RECITALS

- A. The Assignee is the applicant named in the Australian provisional Patent Application and the International Patent Application set out in the Schedule ("the Patent Applications") in respect of the invention the title of which is set out in the Schedule ("the Invention").
- B. The Assignor is the inventor of the Invention.
- C. The parties have agreed that all rights in relation to the Invention are to be owned by the Assignee.
- D. The parties have executed this Deed to confirm the Assignee's ownership of all rights in relation to the Invention and the Patent Applications, and in consideration of the payment of the sum of \$1.00 by the Assignee to the Assignor, receipt of which is acknowledged by the Assignor.

ASSIGNMENT

- 1. The Assignor assigns absolutely to the Assignee at the date of this Deed the whole of any rights the Assignor may have throughout the world in relation to:
 - (a) the invention, including but not limited to the right to apply for the grant of a patent in respect of the invention in any country of the world; and
 - (b) the Patent Applications, including but not limited to the right to claim priority from the Patent Applications in respect of applications made for the grant of a patent anywhere in the world; and

- (c) the right to bring legal proceedings, and to obtain any relief to which the Assignor would have been entitled but for this paragraph, in respect of any infringement of its rights in relation to the Invention which occur before or after the date of this Deed.
2. The Assignor agrees to provide any assistance reasonably required by the Assignee in order to give full effect to this Deed (including but not limited to the execution of any documents). The Assignor irrevocably appoints each of the directors of the Assignee as the Assignor's attorney to do all acts and execute all documents which the Assignor is obliged to do or execute by this clause.
3. The Assignee shall be responsible for paying the costs of preparation and execution of this Deed and for any stamp duty payable in respect of this Deed or the assignment.


