This document is an ASSIGNMENT made by ASSIGNORS:

IN CONSIDERATION of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is acknowledged:

I. Assignment.

The ASSIGNORS sell and assign to the ASSIGNEE, and to the ASSIGNEE's successors and assigns, their entire interest in the design set forth in the application shown in the Schedule hereto (hereinafter the "said application").

The ASSIGNORS acknowledge that their entire beneficial interest in the design to which the above application relates is irrevocably vested in the ASSIGNEE, including the right to apply for protection in all countries abroad and the right to claim priority under any International conventions for such application(s), and assent to the making of any such application(s) and any substitutes, refiles, divisionals, or continuations resulting from any such application(s), with or without priority claims. The ASSIGNORS acknowledge that the ASSIGNEE shall hold all right, title and interest in the design as fully and completely as they would have been held by the ASSIGNORS had the ASSIGNMENT not been made, including any right, title and interest in and to any causes of action for infringement, and the right to sue and collect damages for any infringement.

2. **Other Matter Encompassed.**

This sale and assignment extends to the previously noted matter, and also (a) any related substitute refiled, divisional, or continuation applications filed in the United States and elsewhere; (b) any subsequent design application(s) filed in the United States or elsewhere claiming the benefit of priority to this or any of the aforementioned application(s); (c) any registrations issuing out of any of the aforementioned application(s), and any reissues or extensions of such registrations; and (d) any other design application(s) or registrations relating to the design set forth in the application(s) identified above.

3. **Assignor Certification of Ownership.**

The ASSIGNORS covenant that they have the full right to convey their entire interest in the design to the ASSIGNEE, and that they have not executed and will not execute any agreement in conflict with this ASSIGNMENT.

4. **Assignor Assistance in Securing Rights.**

The ASSIGNORS covenant that they will at any time and upon request execute and deliver any and all papers that may be necessary or desirable to perfect the title in the design, or the title in any application(s) regarding the design or in any registrations that may be granted for the design. If the ASSIGNEE or its successors or assignees desire to make substitute, refile, divisional or continuation applications for the design, or to secure a reissue or extension of a registration for the design, or to file a disclaimer relating to the design, or to make an application for a corresponding registration in any foreign country, the ASSIGNORS covenant that they will at any time and upon request sign all papers, make all rightful oaths, and do all lawful acts necessary for the purpose, but at the expense of the ASSIGNEE.

The ASSIGNORS covenant that they will at all times communicate to the ASSIGNEE, its successors, assigns, and legal representatives, all facts relating to the design and any application(s) or registrations relating to the design known to them, and testify as to these facts in interferences or other litigation when requested to do so, but at the expense of the ASSIGNEE.




