PATENT CONTRIBUTION AGREEMENT

THIS PATENT CONTRIBUTION AGREEMENT (this "**Agreement**") is entered into as of July 12, 2010 by and between Discovery Communications, Inc., a Delaware corporation ("**DCI**"), and Discovery Communications, LLC, a Delaware limited liability company ("**DCL**"), on behalf of themselves and their affiliates (collectively, "**Contributor**"), Discovery Patent Licensing, LLC, a Delaware limited liability company ("**Member**"), and Discovery Patent Holdings, LLC, a Delaware limited liability company (the "**Company**").

RECITALS

WHEREAS, Contributor desires to contribute any and all of its right, title and interest in and to the Contributed Patents and Litigation (as defined below) to the Company; and

WHEREAS, the Company desires to accept the Contributed Patents and Litigation in exchange for the issuance of membership interests in the Company to Member, a wholly owned subsidiary of DCL; and

WHEREAS, as a result of the contribution and the issuance of membership interests contemplated hereby, the Member will own all of the equity interests of the Company.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties agree as follows:

1. Contribution of Contributed Patents and Litigation. Contributor hereby contributes and assigns to the Company any and all of its right, title and interest in and to (a) the patents and patent applications identified on Schedule 1 hereto, together with all divisions, continuations, continuations-in-part, reexaminations, reissues, extensions and renewals of such patents and patent applications (and the right to apply for any of the foregoing) ("**Patents**"); and (b) all rights to causes of action and remedies related to the Patents (including, without limitation, the right to sue for past, present or future infringement of the Patents), and including, without limitation, all claims for infringement of the Patents brought or maintained by Contributor against Amazon.com, Inc. and/or its affiliates ((a) and (b), collectively, the "**Contributed Patents and Litigation**").
2. Contribution Consideration. In consideration for the contribution to the Company of the Contributed Patents and Litigation by Contributor, the Company shall issue to Member one hundred percent (100%) of the membership interests in the Company.
3. Receipt of Contributed Patents and Litigation. The Company accepts the contribution and assignment by Contributor of the Contributed Patents and Litigation to the Company. The Company acknowledges and agrees that such contribution and assignment are on an "AS IS" basis, that the Patents remain subject to all existing licenses and other encumbrances, and that the Company will respect such existing licenses and other encumbrances.
4. Miscellaneous. Contributor agrees to take or cause to be taken such further actions, and to execute, deliver and file or cause to be executed, delivered and filed such further documents and instruments, as may be reasonably required or requested in order to effectuate fully the purposes, terms and conditions of this Agreement. This Agreement shall be governed

by and construed in accordance with the laws of the State of Delaware, without giving effect to the choice of law principles thereof.
