
AGREEMENT

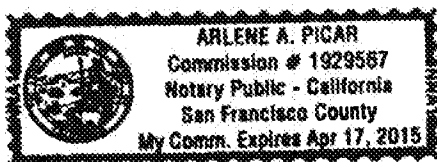
