

We further agree, without any payment by SPN other than actual expenses incurred, to communicate to SPN, its representatives or agents, any fact relating to said Invention or improvements thereon, including evidence for ex parte or inter partes legal proceedings, whenever requested; furnish to SPN any data, information, exhibits, memoranda, or other evidence in our possession relating to said Invention or improvements thereon; testify in any ex parte or inter partes legal proceedings whenever requested; and execute and deliver, upon request, all lawful papers required to make any of the foregoing provisions effective.

This Assignment shall be deemed to have been made in and construed in accordance with the laws of Switzerland, excluding any choice of law rules that may direct the application of the laws of any other jurisdiction.


