TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT

 - (b) authorizes the recordation of this Release with the USPTO at Borrowers' expense.
- SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
