right, title and interest in and to the same, for the sole use and enjoyment of said "Assignee", its successors and assigns.

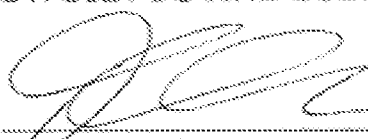

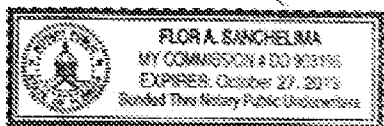
