



Coridea NC1, Inc. (the “**Corporation**”), a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the “**General Corporation Law**”),

DOES HEREBY CERTIFY:

1. Pursuant to Section 242 of the General Corporation Law, this Certificate of Amendment to Second Amended and Restated Certificate of Incorporation (this “**Amendment**”) amends the provisions of the Second Amended and Restated Certificate of Incorporation of the Corporation (the “**Certificate**”).

2. This Amendment has been approved and duly adopted by the Corporation’s Board of Directors and written consent of the stockholders has been given in accordance with the provisions of Sections 228 and 242 of the General Corporation Law, and the provisions of the Certificate.

3. The first paragraph of Article 1 of the Certificate is hereby amended and restated in its entirety to read as set forth below:
