ASSIGNMENT OF PATENT

WHEREAS, I, CHRISTOPHER BERMAN, Citizen of United States of America, residing at 915 Newsome Street, Mount Airy, North Carolina 27030 (hereinafter referred to as "**ASSIGNOR**") have invented and own a certain invention entitled SYSTEM AND METHOD FOR MODULAR TURRET EXTENSION for which application for Letters Patent of the United States of America was filed on May 21, 2013, under application no. 13/899,413 and which claims priority to United States Provisional Application 61/649,817, filed May 21, 2012; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, **ASSIGNOR** hereby sell, assign, transfer and set over unto **ASSIGNEE**, its successors and assigns, the full and exclusive right, title and interest to said invention and to all Letters Patent or application or similar legal protection, not only in the United States and its territorial possessions, but in all countries foreign thereto to be obtained for said invention by said application, and to any continuation, division, renewal, substitute or reissue thereof or any legal equivalent thereof in the United States or a foreign country for the full term or terms for which the same may be granted, including all priority rights under the Paris Convention for the Protection of Industrial Property; and **ASSIGNOR** hereby authorize and request the United States Commissioner of Patents and Trademarks and any officials of foreign countries whose duty it is to issue patents or any legal equivalent thereof to issue said patents and equivalents to said **ASSIGNEE**, its successors and assigns, in accordance with this **ASSIGNMENT** and hereby transfers all rights of action, power and benefit belonging to or accruing from the invention including the right to undertake proceedings to recover past and future damages and claim all other relief in respect of any acts of infringement thereof whether such acts shall have been committed before or after the date of this **ASSIGNMENT**.

ASSIGNOR hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this **ASSIGNMENT**;

ASSIGNOR further covenant that **ASSIGNEE** will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to **ASSIGNOR** and that **ASSIGNOR** will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to **ASSIGNEE** or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents in the

United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
