TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of September 6, 2013 ("Release"), is made by **WELLS FARGO BANK, N.A.**, a national banking association, as Agent ("Agent"), in favor of **INTERACTIVE MEDIA HOLDINGS, INC.**, a Delaware corporation, **SPECIFIC MEDIA LLC**, a California limited liability company, **MYSpace LLC**, a Delaware limited liability company, **XUMO LLC**, a Delaware limited liability company, **SITE METER, INC.**, a Delaware corporation, **BBE LLC**, a California limited liability company, **VINDICO LLC**, a Delaware limited liability company, **INTERACTIVE RESEARCH TECHNOLOGIES, INC.**, a California corporation, and **ILIKE, INC.**, a California corporation (each a "Grantor", and collectively, the "Grantors").

WHEREAS, pursuant to that certain Guaranty and Security Agreement dated as of March 20, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantors and Agent, and the Trademark Security Agreement dated as of March 20, 2012 ("Patent Security Agreement") by and among the Grantors and Agent, Grantors granted to the Agent, for the benefit of the Lender Group and the Bank Product Providers (the "Secured Parties"), a continuing security interest in all of Grantors' right, title and interest in, to and under the Patent Collateral; and

WHEREAS, the Patent Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on March 21, 2012 at Reel 027905 Frame 0853.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Parties, and Grantors agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Patent Security Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Parties, hereby:


(a) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and

(b) represents and warrants that it has full authority to execute and deliver this Release.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
