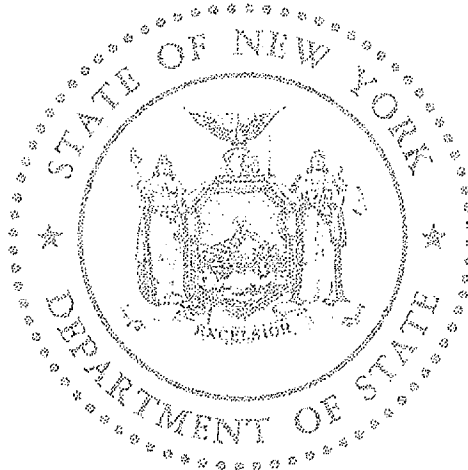

FUJIFILM U.S.A., INC.

Under Section 904 of the New York Business Corporation Law

The undersigned corporations do hereby certify that:

FIRST: The name and state of incorporation of each constituent corporation which is a party to the merger is as follows:

SECOND: The name of the surviving corporation of the merger is FUJIFILM U.S.A., Inc., a New York corporation (the "Surviving Corporation").

THIRD: The authorized capital stock of each constituent corporation which is a party to the merger is as follows:

FOURTH: The merger is permitted by the laws of the jurisdiction under which FGSU is incorporated.

FIFTH: The Certificate of Incorporation of FUSA in effect immediately prior to the merger shall be the Certificate of Incorporation of the Surviving Corporation until amended in accordance with applicable law, except that Article FIRST of the Certificate of Incorporation of the Surviving Corporation is restated in its entirety, upon consummation of the merger, to provide as follows:

“FIRST: The name of the corporation is FUJIFILM North America Corporation.”

SIXTH: This Certificate of Merger shall be effective on January 1, 2010.


SEVENTH: The Certificate of Incorporation of the Surviving Corporation was filed by the Secretary of State of the State of New York on October 28, 1965.

EIGHTH: The merger has been authorized by unanimous written consent of the respective Boards of Directors and shareholders of each constituent corporation which is a party to the merger.


