ASSIGNMENT

The Commissioner of Patents and Trademark is requested to issue such Letters Patent in accordance herewith. I covenant that I am the lawful owner of the said application, apparatus, inventions, discoveries and improvements, that the same are unencumbered, that no license has been granted to make, use, or vend the said apparatus, inventions, discoveries or improvements or any of them, and that I have the full right to make this Assignment.

And for said consideration, I agree that I will communicate to said Assignees or the representatives thereof any facts known to me respecting said apparatus, inventions, discoveries and improvements, and will, upon request, but without expense to me, testify in any legal proceedings, sign all lawful papers, execute all divisional, reissue, continuation, continuation-in-part, renewal and/or extension applications, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said Assignees or by counsel for said Assignees, to assist or enable said Assignees to obtain and enforce full benefits from the rights and interests herein assigned, and, in the event of any application or Letters Patent assigned herein becoming involved in Interference, to cooperate to the best of the ability of the undersigned in the matters of preparing and executing the preliminary statement and giving and

producing evidence in support thereof. This Assignment shall be binding upon my heirs, executors, administrators and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors and/or assigns, as the case may be, of said Assignees.

And for said consideration, the undersigned hereby agrees to execute, at the request of said Assignees, all documents in connection with any application for foreign letters patent therefore.

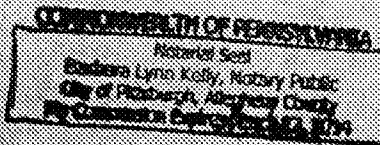

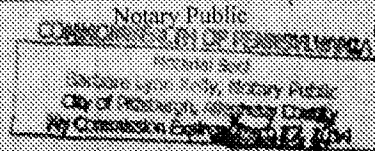

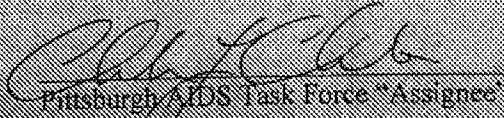
