INTELLECTUAL PROPERTY ASSIGNMENT

In consideration of the premises and mutual covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Seller hereby irrevocably sells, conveys, transfers and assigns to the Buyer, and the Buyer hereby accepts the sale, conveyance, transfer, and assignment from the Seller, of all of the Seller's worldwide right, title and interest in and to all of the Seller's Intellectual Property, including that which is identified in Schedule A, and all of Seller's Software identified in Schedule B, together with the goodwill associated therewith and which is symbolized thereby, including the right to sue and recover damages for infringement, misappropriation, or other claims and rights relating to or under any of the above, whether arising prior to or subsequent to the date of this Assignment, in both domestic and foreign jurisdictions. This Assignment includes any and all associated registrations and applications with respect thereto, and any and all renewals and extensions thereof, that may hereafter be secured under the laws now or hereafter in effect in the United States of America and in any other jurisdiction, the same to be held and enjoyed by Buyer from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Seller had this Assignment not been made. Seller hereby agrees to execute any documents and/or instruments as Buyer may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Buyer, or to aid and assist in the collection of or reducing to Buyer's possession, all of such Intellectual Property, and covenants that Seller will do all things necessary to give full effect to this Assignment, including obtaining and executing any written agreements and other instruments to enable Buyer to record and enforce this Assignment.

This Assignment is subject to all of the terms, conditions and limitations set forth in the Purchase Agreement (including, but not limited to, the representations, warranties, covenants and indemnities set forth in the Purchase Agreement). In the event of any conflict or inconsistency between the terms of this Assignment and terms of the Purchase Agreement, the terms of the Purchase Agreement will prevail. Nothing contained herein will be deemed to alter, modify, expand or diminish the terms of the Purchase Agreement.

THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO ANY LAW OR RULE THAT WOULD CAUSE THE LAWS OF

ANY JURISDICTION OTHER THAN THE STATE OF NEW YORK TO BE APPLIED. EACH PARTY WAIVES THE RIGHT TO A TRIAL BY JURY IN ANY DISPUTE RELATING TO OR ARISING OUT OF THIS AGREEMENT, THE SUBJECT MATTER HEREOF OR THE TRANSACTIONS CONTEMPLATED HEREBY, AND AGREES TO TAKE ANY AND ALL ACTION NECESSARY OR APPROPRIATE TO EFFECT SUCH WAIVER.

This Assignment may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.

WHEREFORE, the parties have caused their authorized representatives to execute and deliver this Assignment as of the date first written above.
