AND I/WE HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND I/WE HEREBY further covenant and agree that we will communicate to the said Assignee, its successors, legal representatives and assigns, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries. I hereby irrevocably appoint said HERCUTECH INC. as my/our true and lawful attorney-in-fact on our and its behalf and in our and/or its name, place and stead to execute, any further documents or instruments and do any and all further acts that may be deemed necessary or desirable by HERCUTECH INC., to vest in the assignor, its successors and assigns, the title whose conveyance is made hereby and to enable such

title to be recorded in the United States and all other countries, and to enable HERCUTECH INC. to sustain or reissue any said letters Patent granted, and to maintain, perfect, support and protect the right, title and interest of said HERCUTECH INC. its successors and assigns, in and to the said invention, and any Letters Patent granted, particularly in cases of interference and litigation.
