title, and interest in and to said improvement and application.





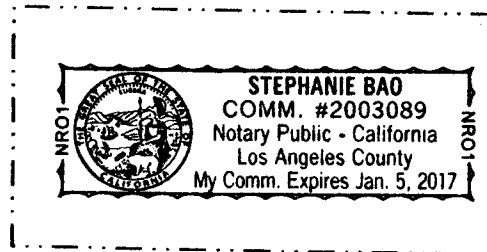
