**WAGERING GAME FOR AWARDING ATTRIBUTES  
IN A PLURALITY OF PLAYS**

for which we have made application for United States Letters Patent, the said application having been filed on January 28, 2010, as Application No. 61/299,236;

We also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and




