
AND WHEREAS the Assignee is desirous of obtaining a Patent or Patents in the Republic of Ireland and in other countries for the said invention or inventions


AND WE HEREBY assent to the making of applications for such Patents by the Assignee in its own name

IT IS HEREBY AGREED between the parties that this assignment shall be effectively dated 15th February 2011




