This assignment shall be governed by the laws of the State of California, United States of America.

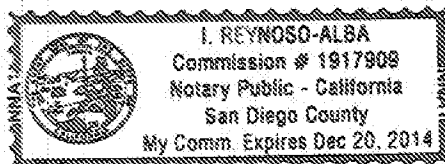

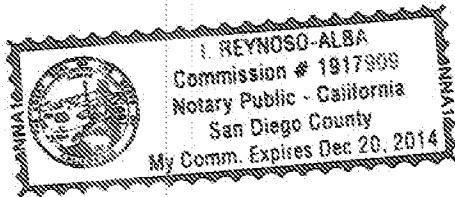

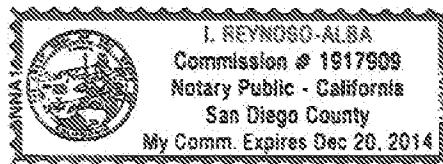
