ASSIGNMENT AGREEMENT

On the date shown below and for good and valuable consideration the receipt of which Brett R. Glass and Nicole E. Glass ("we") acknowledge, we made the following assignment and promises to Gift Card Impressions, LLC ("Assignee"), a Kansas limited liability company having a principal place of business at 415 Delaware Street, Suite B, Kansas City, MO 64105, in connection with our invention as listed on the attached Schedule A ("the Invention").

1. We assign, transfer, and convey to Assignee the entire right, title and interest in and to

- (a) the Invention;
- (b) application for United States Letters patent listed on Schedule A attached hereto and made a part hereof, and any applications from which said application listed on Schedule A claims priority;
- (c) any patent applications claiming priority from the above referenced patent application and any patents issued pursuant to, or as a result of such patent application;
- (d) all applications for patent, or similar legal protection, which may be filed in any country or countries foreign to the United States with respect to the Invention;
- (e) all patents which may be granted for the Invention in any country or countries foreign to the United States; and
- (f) all extensions, renewals, reissues, divisions, and continuations (or their legal equivalents) of any applications or patents referred to above.

2. We authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States whose duty it is to issue patents or similar legal protection on applications, to issue to Assignee all Letters Patent or similar legal protection for the Invention or improvements.

3. We agree that, upon the request of Assignee, we will


- (a) execute any and all divisional, continuation and renewal applications for the Invention or improvements;
- (b) execute any supplemental oath relating to the Invention or improvements;
- (c) execute any applications for reissue or extension of any Letters Patent that may be granted upon the applications:

- (d) cooperate to the best of our ability in connection with any interference proceeding, including but not limited to, cooperation in connection with preparing the preliminary statement and giving and producing evidence in support of such preliminary statement;
- (e) perform any and all affirmative acts to obtain Letters Patents and vest all right in such Letters Patents in Assignee; and
- (f) perform such additional acts as Assignee may deem necessary or expedient in connection with any of the matters stated above.

4. We covenant and warrant that as of the effective date of this Assignment Agreement, we are the true and lawful owners of the entire right, title, and interest in the Invention, application for Letters Patent, and any Letters Patent which may issue under said application, and have the full right and power to convey the same; that the same are free and clear of all liens, charges and encumbrances whatsoever; and that we have not executed and will not execute any agreement in conflict with this Assignment Agreement.

5. This Assignment Agreement is binding upon, shall inure to the benefit of, and shall be performed by the parties named, their heirs, administrators, legal representatives, successors and assigns.

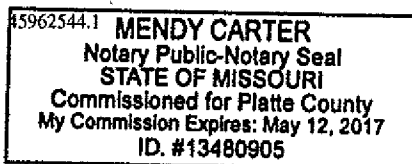

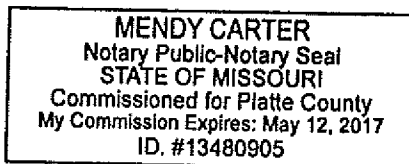
