ASSIGNMENT

- (g) all rights to collect royalties, license fees, and all other forms of payment on account of the Patent.

Assignor hereby authorizes the United States Patent and Trademark Office to issue any and all re-examination and re-issue patents that may be granted upon said Patent in the name of Assignee, as assignee to the entire right, title, and interest therein.

The terms and conditions of this Assignment will inure to the benefit of Assignee, its successors, assigns and other legal representative and will be binding upon Assignor, its successors, assigns, and other legal representatives.
