

## ASSIGNMENT

WHEREAS, I, Peter John Deacon Wickham whose postal address is shown below, have made a certain new and useful Invention relating to RESPIRATORY APPARATUS WITH IMPROVED APNEA DETECTION, for which application has been made for Letters Patent of the United States, which application may be identified in the United States Patent Office as Application Serial No. 60/228,630, filed on August 25, 2000 titled RESPIRATORY APPARATUS WITH IMPROVED APNEA DETECTION; and

UPON SAID CONSIDERATION, I hereby covenant and agree with ResMed R&D that I will not execute any writing or do any act whatsoever conflicting with these presents, and that I will, at any time upon request, without further or additional consideration, but at the expense of ResMed R&D, execute such additional assignments and other writings and do such additional acts as ResMed R&D may deem necessary or desirable to perfect ResMed R&D's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, renewal, reissued or extended Letters Patent of the United States, or of any and all foreign countries, on said Inventive Subject-matter, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions

involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of all parties.
