Lifetime does hereby sell, assign, transfer and convey to LiveWell, its successors, legal representatives and assigns, all claims for damages and all of the remedies arising out of any infringement of the Patents and Patent Applications which may have accrued prior to the date of this assignment or may accrue, including, but not limited to, the right to sue for and collect and retain damages for past infringements of the Patents and Patent Applications;

Lifetime hereby covenants and agrees that it will communicate to LiveWell, its successors, legal representatives and assigns, any facts known to respecting the Patents and Patent Applications immediately upon becoming aware of those facts, and that it will testify in any legal proceeding involving any or all of the Patents and Patent Applications, will sign all lawful papers, execute all divisional, continuing, continuation-in-part, and reissue applications, make all rightful oaths, and generally do everything possible to aid, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the Patents and Patent Applications in all countries, in each case, at the expense of LiveWell.

Lifetime shall, at the request of LiveWell, execute any documents reasonably necessary to supplement or fulfill the provisions of this Assignment of the Patents and Patent Applications, in each case, at the cost and expense of LiveWell.

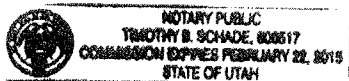
