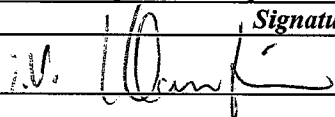

2. Der Aufgabenkreis umfaßt vorerst:
die Gesundheitssorge, die Vermögenssorge und die Aufenthaltsbestimmung.
3. Das Gericht wird spätestens bis zum 30.06.2008 über eine Aufhebung oder Verlängerung der Betreuung beschließen.
4. Die Entscheidung ist sofort wirksam.

Gründe:

Es ist erforderlich, für den Betroffenen gemäß § 1896 Abs. 1 BGB im Wege der einstweiligen Anordnung einen Betreuer mit dem oben umschriebenen Aufgabenkreis zu bestellen. Er ist aller Voraussicht nach nicht in der Lage, diese Angelegenheiten selber zu besorgen. Er erlitt einen Mediainfarkt mit Einblutung, befindet sich weiter im Koma und kann notwendige Entscheidungen auf absehbare Zeit nicht selbst treffen.

Dies folgt aus dem Ergebnis der Beweisaufnahme, insbesondere aus dem ärztlichen Zeugnis Dr. Poli vom 31.12.2007 i.V.m. der ärztlichen Auskunft Dr. Rinzos vom 09.01.2008, sowie dem persönlichen Eindruck von dem Betroffenen am 09.01.2008.

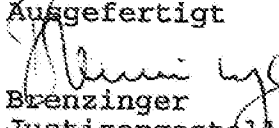
Bezüglich der Auswahl des Betreuers wird noch eine Stellungnahme der Betreuungsbehörde eingeholt. Insofern bleibt eine Änderung der Entscheidung vorbehalten. Auch wird erst nach Vorliegen letzterer Stellungnahme und eines Gutachtens über den endgültigen Umfang der Betreuung entschieden werden.

Die Anordnung der sofortigen Wirksamkeit beruht auf § 69 a und 70 g FGG.

Rechtsmittelbelehrung

Gegen diese Entscheidung ist das Rechtsmittel der Beschwerde zulässig. Sie ist beim Amtsgericht Heidelberg oder beim Landgericht Heidelberg einzulegen.

Decision
of January 10, 2008

Guardianship for Volker Zimmer, born June 24, 1964,
residence at Burgstr. 17, 67229 Laumersheim
currently Neurological Clinic, 69120 Heidelberg
- person concerned -

1. The guardianship established for the person concerned in the way of a provisional arrangement is expanded and prolonged.

The guardian remains the brother of the person concerned,

Mr. Klaus Zimmer

Bernkastelerstr. 14, 54497 Mohrbach.

2. The scope of functions comprises, for now:

health care, care for legal property, and right to decide place of residence.

3. The court will decide on cancellation or extension of the guardianship at the latest on June 30, 2008.

4. The decision is effective immediately.

Reasons:

It is necessary to appoint a guardian with the scope of functions described above for the person concerned pursuant to §1896 subsection 1 BGB [Civil Code] in the way of a provisional arrangement. In all likelihood he will not be in the position to take care of these matters himself.

He suffered a middle cerebral artery stroke with hemorrhaging, furthermore is in a coma, and cannot make the necessary decisions himself for the foreseeable future.

This follows from the result of the hearing of evidence, particularly from the medical testimony of Dr. Poli of December 31, 2007 in connection with the medical information of Dr. Rinzos of January 9, 2008, as well as from the in-person impression of the person concerned on January 9, 2008.

With respect to the selection of the guardian, comments from the guardian authority will still be obtained. In this respect, the right to change the decision is reserved. Also, a decision will be made only after receipt of said comments and an opinion on the final scope of guardianship.

The arrangement of the immediate effectiveness touches upon §69a and 70g FGG [voluntary jurisdiction law].

Instructions on your right to appeal

You have the right to appeal this decision. It is to be filed with the Heidelberg Municipal Court or the Heidelberg Regional Court.

Filing is performed by submitting a notice of appeal or by entering it into the records at the court office of one of the courts mentioned. The appeal can also be filed by entering it into the records at the court office of a different municipal court.
