The Attorney of Record is hereby authorized to insert the Serial Number and filing date in the above blank spaces when received from the Patent and Trademark Office.

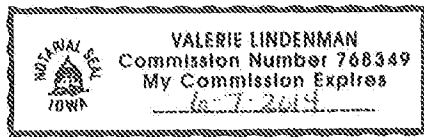

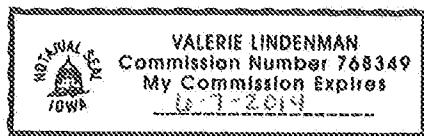
