ASSIGNMENT AND AGREEMENT

WHEREAS, Sanjiv Kapoor, Michael Gasda, Virginia Osterman, and Ken Bauhof (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled ***Oxidation Process for Interconnects and End Plates*** for which a U.S. provisional application was submitted on September 12, 2012, as Application No. 61/700,135, and for which a U.S. non-provisional application was submitted on August 19, 2013, as Application No. 13/969,787.


