WHEREAS, We Andrew Thomas Baker of ~~Alpharetta~~, Georgia; Theresa Michelle McCoy of Cumming, Georgia; Stephen Avedis Baratian of Roswell, Georgia; and Charles Wilson Colman of Marietta, Georgia have invented an improvement in ABSORBENT STRUCTURE HAVING THREE-DIMENSIONAL TOPOGRAPHY ON UPPER AND LOWER SURFACES (File KCC 4945; K-C 18,243) and have executed an application for a United States patent based thereon, assigned Serial No. 10/460,882, filed June 13, 2003;

TO BE HELD AND ENJOYED by said ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by us had no sale and assignment of said interest been made;

AND We hereby authorize and request the Commissioner of Patents of the United States of America to issue any and all United States patents which may be granted upon said United States applications or any of them, or upon said invention or any part thereof, to said ASSIGNEE;


