**DEPOSITION OF DISCRETE NANOPARTICLES
ON AN IMPLANT SURFACE**



We further authorize and direct the ASSIGNEE and its attorneys to insert above the application number of said application now identified as Docket No. 47168-00354USPT as soon as the same shall have been made known to them by the U.S. Patent and Trademark Office.


