ASSIGNMENT AND AGREEMENT



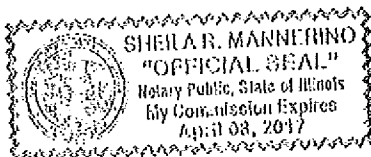


