PATENT ASSIGNMENT

 - (d) any other rights in the inventions described in any of (a), (b) or (c); (all of the foregoing in (1), collectively, the "Assigned Patents");
 - (2) the right to sue third parties for infringement (including but not limited to damages and injunctive relief) of any of the foregoing in (1) accruing based on activities occurring prior to the execution date hereof; and
 - (3) any current or future right to receive royalties based on any of the foregoing in (1) or (2); (all of the foregoing in (A), collectively, the "Assigned Rights"); and
- (B) agrees upon request (and at the expense) of Yahoo! (or its successors, assigns or legal representatives) to, and if Seller is unable or unwilling to do so authorizes Yahoo! to act in Seller's name to:
- (1) execute all oaths, assignments, powers and any other papers;
 - (2) testify in any proceeding; and
 - (3) otherwise take any action, and fully cooperate with Yahoo!;
- in each case, related to securing and enforcing Yahoo!'s rights related to this Agreement; and
- (C) agrees to deliver to Yahoo! accurate copies of all material correspondence with counsel, in Seller's or its counsel's possession, relating to ownership, filing, prosecution, infringement, validity, or enforceability of, the Assigned Patents, to the extent such has not already been delivered.

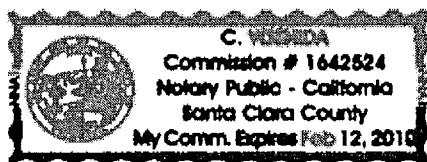
