AND FURTHER pursuant to and for the consideration set out in this agreement the Assignors hereby assign to the Assignee absolutely all its right, title and interest in and to all trade marks, including all statutory and common law rights attaching to any trade mark, together with the goodwill of the business relating to the goods or services in respect of which the trade marks are registered or used;


AND FURTHER the Assignors hereby undertake to do any reasonable act at the request and expense of the Assignee as may be necessary to give effect to the assignment of the said rights and to facilitate the filing, obtaining, maintenance or enforcement of protection for any Intellectual Property in the name of the Assignee.
